FINANCIAL ASSISTANCE POLICY

All applications for financial assistance are confidential. Financial assistance is awarded according to each applicant's ability to pay and the funds we have available. Financial awards are not 100%. Any remaining tuition balances must be paid in full as described below.

EXETER AREA YMCA: Balances must be paid monthly.

YMCA CAMP LINCOLN: Balances must be paid in full before the start of the program.

YMCA SCHOOL AGE CHILD CARE: Balances must be paid monthly. Eligibility and financial awards for program tuition are based on household income, number of children enrolled in programs and total program tuition costs. Changes in enrollment will affect financial awards and overall tuition balances. Applicants are required to pay the registration fee of the program for which they are requesting. We strongly encourage families to apply for child care assistance through the State of New Hampshire before applying for financial assistance from Southern District YMCA. FINANCIAL ASSISTANCE DECISIONS

EXETER AREA YMCA: Decisions are made throughout the year and will be made within 10 business days of receipt of a complete application

YMCA CAMP LINCOLN: Financial awards are made the first week of each month, beginning in February. Decisions will be made and sent by email by the fifteenth of each month.

YMCA SCHOOL AGE CHILD CARE: Financial awards for school age child care are made throughout the school year. Decisions will be made within 10 business days of receipt of a complete application.

HOW TO APPLY

Please complete the application and return it, with copies of the required documents and an application letter that explains any special circumstances that may help them understand your situation and why the YMCA is an important part of your family's experience. Please send these items to the Exeter Area YMCA, YMCA Camp Lincoln or YMCA School Age Child Care.

All required documents of income and expenses must accompany the application in order for it to be processed.
